
Financial Modeling: Building a Three-Statement Model "From Scratch"

Other advanced topics include understanding and controlling circularity errors, troubleshooting, sensitivity/scenario analysis and discounted cash flow valuations.

The workshop requires a laptop with Microsoft Excel. Both Mac and PC users are welcome, however the content is optimized for Windows based systems. For the best experience, a PC is strongly encouraged. Mac users will be provided with a setup guide prior to the workshop.

To gain the most from the workshop, you should have taken or be currently enrolled in an introductory-level accounting/corporate finance course. A basic understanding of Excel is also essential to the overall learning experience.
